VOICES OF ADOPTED TEXANS. [AMY GREGORCYK]

I was born prematurely in Ft. Worth, TX. My Biological Mom made the most selfless decision and gave me up for someone else to raise, as she could not. I had an amazing childhood with loving and caring parents and community. All I knew about my biological parents was hair color, weight, height and favorite school subjects. As a kid, that information was "cool". As I got older, that information was not enough. What about diseases and hereditary conditions?

My desire to know about my medical history intensified when I became pregnant with my daughter in the fall of 1995. My pregnancy was difficult and my baby girl was delivered prematurely in April. By the grace of God, we had her 33 days here on earth. I went on to have 3 miscarriages. Since my daughter's father was adopted too, we had a double whammy. Doctors asked again if we knew our medical history. The answer was always no. We had none.

I eventually got my "records" from the agency I was adopted from. Much information was deleted, but my medical record was eerily similar to my daughters. I learned that I was resuscitated several times. I learned that that my Bio-Mother had a tumor removed from her stomach at the age of 10. This is information that MY PARENTS AND I SHOULD HAVE BEEN INFORMED ABOUT.

Unfortunately, I do not have biological children. Yet, I am so glad that recently I obtained my family medical history and reunited with biological family through DNA. I learned that I have a genetic condition, where my body will not absorb the folic acid without the help of a binder. Similar pregnancy losses run throughout my biological family. If I had this information, I could have saved the lives of my children, but painfully, I was not given that privilege.

Access to my medical records, while too late to save my children, has helped me let go of the guilt and hurt due to the losses of my babies. All adoptees should have access to their medical information! It can save lives! ★
